

## OCEAN STATE INTERNATIONAL DUAL PROJECTION EXHIBITION

**YOU ARE INVITED** – The Photographic Society of Rhode Island (PSRI) invites all photographers everywhere to submit slides or digital images to the **OCEAN STATE INTERNATIONAL DUAL PROJECTION EXHIBITION**. All phases of the exhibition will be conducted in accordance with the recommended practices of the Photographic Society of America.

### CONDITIONS OF ENTRY –

You may enter either slides or digital images, but not both. There is no restriction on subject matter but we reserve the right to remove offensive images.

Report cards will be sent to each entrant within 5 days after the judging. **Our acceptance rate is normally 30-35%**. An electronic catalog will be sent via email to all entrants. No printed catalogs will be available. Print-ready versions of the catalog can be emailed to entrants upon request.

Entries must originate as photographs (image/captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright by the entrant. Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates. All final work must be on photographic film or on electronic file.

Once an image has been accepted in the Ocean State, that same image, or a like “in camera” or a reproduction duplicate of that image may not be reentered in that exhibition regardless of its title. The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to exhibition rules and conditions or deemed inappropriate.

### SLIDES:

A total of four (4) slides, **exposed by the entrant**, may be submitted in 2” x 2” mounts only. Ready mounts (cardboard, plastic or glass) are acceptable.

Slides must be clearly marked with the title, projection sequence number (1, 2, 3, 4), maker’s name and address, and must be spotted in the lower left hand corner as viewed normally. All possible care of your slides will be taken, but no responsibility will be assumed for any loss or damage during the exhibition or in transit.

**DIGITAL:** There are two methods available for entry of digital images.

#### Internet Entry (choose one):

1. Go to <http://psri.us> and click on the OCEAN STATE EXHIBITION link. From this link you will be able to submit an on-line entry form, upload your entries to our server and pay your entry fee via PayPal.

2. Go to <http://www.psaexhibition.com/exh-model/2011-ocean-1-enter.php> and follow the instructions.

**File naming will be done automatically for images submitted via our Web site based on the identity information of the submitter.**

**Mail Entry:** There is no longer an option for mail entry. All digital entries must be submitted via the web.

### FOR ALL DIGITAL IMAGE:

**SIZING YOUR IMAGES:** Images must be sized to fit into a box, 1024 pixels wide by 768 pixels high. They must be in jpeg format with an image quality no higher than 8 (high). The file size of each image must not exceed 800KB. sRGB is recommended for best projected image quality.

Images that do not meet the above mentioned requirements may be disqualified!

**All images will be distributed equally throughout four rounds of judging.**

Entry fee to be paid with **US dollars** via **PayPal** to [heyyjude@yahoo.com](mailto:heyyjude@yahoo.com). **Online submissions via our Web site will not be completed until the submission fee is paid via PayPal, you may use your credit card when making this payment at the PayPal Web site.**

**Payment note\*:** Any individual entrant caught entering as a club member, who is not a member of that club, and paying the club fee in order to enter at the lower fee schedule will be disqualified from the exhibition and his or her partial fee will not be returned.

**CLUB ENTRIES (SPECIAL NOTE)** – Club entries may be a mixture of slides and digital images but all images by any one club member must be either all slides or all digital. Club entries where all entrants are submitting digital images must enter via the digital submission process and paid via Paypal. Special drop down menus have been designed for club entrants. Choose ‘yes’ to designate you are a club entrant and type the name of your club in the box where it asks for this information.

## UPDATES FOR 2011 EXHIBITION – PLEASE READ

Interspersed in the directions above are updates regarding catalogs and mail/digital entries. They are capsulated here for your convenience.

1. All digital entries – including club entries which are exclusively digital entries – must be entered via on-line entry program.
2. On-line entries are available via two portals: [psri.us](http://psri.us) or <http://www.psaexhibition.com/exh-model/2011-ocean-1-enter.php>
3. To promote camera club participation we offer a special lower rate for club members in groups of six or more from the same club. Individual entrants trying to take advantage of the lower fee schedule will be disqualified. If members of a club enter and the club does not reach the minimum six entrants, entrants will be given the opportunity to pay the full individual entry price or their entry will be disqualified.
4. Only full color digital catalogs will be distributed. Paper catalogs are no longer mailed. Print ready digital catalogs can be provided upon request.
